UNITED KINGDOM.

Short Stay Standard Visa-

The UK visitor visa which is also known as the Standard Visitor Visa is a UK short stay visa that allows its holder to stay in the UK for up to 6 months. However, the embassy has the right to issue visas for a shorter period of time. This visa is established for those that wish to travel to the United Kingdom for purposes of:

- * Tourism.
- * To visit family members.
- * Medical treatment.
- * For professional reasons.

Long Term Visitor Visa-

If you visit the UK regularly, you can choose to apply for a long-term Standard Visitor visa instead which is valid for up to 2, 5 or 10 years. A long term visitor visa can be applied for if the applicant can submit proof that frequent visits to the UK would be required over some time, and that the purpose of those visits would remain the same throughout the visa period.

And, of course, the UK's diversity is mirrored in its landscape too. From its rugged coastline studded with gold sand beaches and secret coves, to rolling countryside dotted with patchwork fields and crops of ancient woodland, to vertiginous peaks set above glistening meres and heather-clad moors, via kitschy seaside resorts, pretty-as-a-postcard villages and handsome market towns, there's no shortage of places to visit in the United Kingdom.

Documents Required For UK Visitor Visa

The documentation required for the UK visit visa includes:

- * Personal details
- * Salary and financial details
- * Travel itinerary and travel history
- * Proof that you can fund your stay adequately
- * Proof that you can pay for your air travel to and from the UK
- * Proof that you will leave the UK at the end of the visit

UK Tourist Visa Fees

It costs £89 to apply for a UK Tourist Visa. However for private medical treatment given for 6 up to 11 months and for an academic to do research for up to 1 year the fee is £179. While for a long-term visa for 2 years is £337, £612 for 5 years and £767 for 10 years.

A multiple entry visa permits its holder to come and go as often as they desire while the visa is valid. You do not have to pick the type of visitor visa to apply for; all applicants are automatically considered for multiple entry visas, and single-entry visas are only awarded in exceptional circumstances.

Normally, you need to give biometrics. If your local visa application centre is not open due to COVID-19, there are temporary measures in place for biometrics.

 - * If it's incomplete, we'll return your application without processing it.
 - * If we approve your application, we'll ask you to send us your passport.
- STEP 6** Send us your passport (if we approve your application)
To get your visa, follow the instructions we'll send to you.

Canadian Tourist Visa Fees

The application fee per person for a Canada Visitor Visa is CAD\$100. If you also have to submit the biometrics, that will cost you an additional CAD\$85. So together, the whole cost of just applying for this visa is CAD\$185. In addition to this, you will also have to pay for the passport processing which will cost around CAD\$45.

Tourist Stream Visas in Australia

Visitor visa (subclass 600) Tourist stream (apply outside Australia)

This visa stream lets you visit Australia as a tourist, to go on a cruise or to see family and friends. It lets an applicant stay up to 12 months. The govt. might grant you a stay of 3, 6 or 12 months. It is used to visit friends and family, cruise or have a holiday. You must be outside Australia when you apply for the same. The visa fees for this is from AUD145.

Due to COVID-19, some visa processing times have been affected and applications may take longer to finalise. For Visitors and Working Holiday Makers the processing time is calculated differently depending on when you applied.

Visitor visa (subclass 600) Sponsored family stream

This visa stream lets people who are sponsored, usually by a family member, come to Australia to visit their family members. It lets candidate stay up to 12 months and it costs AUD145. You must be sponsored by an eligible family member who is an Australian citizen or permanent resident. We might ask your sponsor to pay a security bond.

You must be outside Australia when you apply and when we decide your visa.

Visitor visa (subclass 600) Approved Destination Status stream

This visa stream is for citizens from certain areas of China visiting Australia on a tour organised by an approved travel agent. The stay approved is for the period or until the date authorities specify in your grant letter. The application costs AUD145 and the processing time for this visa are based on the age of applications finalised in a given period.

This visa lets citizens of the People's Republic of China (excluding SARs) visit Australia with an organised tour group and you must remain with the organised tour group.

Visitor visa (subclass 600) Frequent traveller stream

This visa stream is for citizens of the People's Republic of China who travel often to Australia for business or personal reasons. The visa can be granted for up to 10 years and one can stay up to 3 months each time you enter. It costs around AUD1,085.

Requirements For An Australian Visa

All applicants must meet the relevant Australian visa requirements that apply to their visa. Each Australian visa type presents different requirements as well as terms and conditions but here are a few general visa requirements.

- * Documents proving the applicant's eligibility (eligibility criteria depend on the visa type)
- * Travel purposes compatible with the visa type
- * Proof of financial means
- * Payment of the relevant Australian visa fee (if applicable)
- * Active email address to receive communications regarding the electronic visa request
- * Meeting the general character and health requirements to visit Australia

GERMANY.

The Western European country of Germany is a beautiful tourist destination attracting millions of visitors every year. With its rich history, majestic castles, and picturesque landscapes, Germany has become one of the most attractive tourist destinations worldwide.

Germany Tourist Visa

Germany is a member state of the Schengen Area so it allows nationals of 62 countries to enter Germany for touristic purposes without the need to obtain a visa. But some countries need visas to travel including India. The short-stay Schengen visa is generally valid for a maximum of 90 days within six months. The processing time for the German tourist/visitor visa highly depends on the application centre and their workload at the time.

How to apply for Germany Tourist Visa?

The procedure to apply for the Germany tourist visa is simple, as follows:

- * Download the visa application form and fill it carefully.
- * Make an appointment at the visa application center or embassy.
- * Pay the visa fees as mentioned.
- * Attend the interview on the date scheduled.
- * Submit all the required information and biometrics.
- * Wait for the response of the representatives.
- * Collect your passport and receive either approval/rejection of the visa.

German tourist/visitor visa fee

The German tourist/visitor visa fee is €80 for adults. Children aged 6-12 are required to pay €40. Nationals of countries that have visa-facilitation agreements with the EU will have to pay €35.

HONG KONG.

Hong Kong, officially known as the Special Administrative Region of the People's Republic of China is a burst of culture and colour. Housing 18 districts, Hong Kong is one of the most heavily populous regions in the world and the city with the most number of skyscrapers in the world. A major port and shopping hub, Hong Kong is the land of an iconic skyline, delectable cuisine, and protected lush nature reserves.

Home to the second-largest sitting Buddha statue, the Tian Tan Buddha, the Frangant Harbour has a majority of Confucian, Buddhist and Taoist followers. While sustaining ancient culture and tradition through architecture and festivities, Hong Kong perseveres to stand as an entertainment hub at the same time. Ocean Park, Victoria Peak, Victoria Harbour and The Peak Tram are some brilliant sites in Hong Kong.

This town of skyscrapers and some of the most beautiful skylines carries out Cantonese and British architectural aspects gained from its colonial period induced with the regional feng shui design. With art being a vital characteristic of this Gourmet Paradise, Hong Kong attracts visitors to one of Asia's biggest cultural festivals, the Hong Kong Art Festival apart from the renowned Chinese New Year Night Parade.

Hong Kong Visit/Transit Visa

To go to Hong Kong for tourism purposes, Indians have to complete the pre-arrival registration online. Hong Kong offers a visa-free stay for citizens of most countries starting typically from 7 days, 14 days, 30 days to 90 days, though this wholly depends on the country in question. Only British nationals are allowed to stay in Hong Kong for up to 180 days without a visa. In order to stay longer than your visa-free period, you need to apply for a visa or entry permit ahead of travelling to Hong Kong. For such stays you need to show proof of funds whether they are adequate to support your stay in the country without work, and you also need to have a return ticket unless you are in transit to mainland China or Macau Special Administrative Region. This category of visa does not allow visitors to take up an employment or establish a business enterprise, or sign up for a course in Hong Kong.

Eligibility Criteria For A Hong Kong Visa For Indians

- * If an Indian citizen is planning to travel to Hong Kong, they need to get a visa first.
- * Since 2017 the government of Hong Kong has introduced a Hong Kong pre-arrival registration or PAR that grants an electronic travel authorisation to Indian citizens to travel to the Hong Kong Special Administrative Region (HKSAR).
- * But you need to get your Hong Kong visa application processed by an OTA who would do the necessary

documentation on your behalf and grant you the Hong Kong eVisa online.

- * The PAR visa travel authorisation comes with a validity of 6 months from the date of approval. It makes it possible to stay in Hong Kong beyond the period of expiry provided the traveller arrives in Hong Kong before the last day of validity and stays at a time for only up to 14 days.
- * The Hong Kong pre-arrival registration is offered to Indian citizens for travelling to Hong Kong when their purpose of visit is business, tourism, visit family and friends or transit -only if they are exiting the airport.

How to apply for Hong Kong Visit/Transit Visa?

- * An applicant should visit the official Government website of Hong Kong for a pre-arrival registration and fill only the correct information.
- * Once the application is submitted, the computer processes the application automatically and the result is notified instantly to the applicant.
- * If the result is successful, the registrant should have the "PAR Notification Slip" printed.
- * An applicant should cross check the entered data on the slip to verify if all the details are correct before signing it.
- * For some reasons, if the PAR is unsuccessful, an applicant should apply for a valid entry visa at the Immigration Department so that he/she is allowed to visit HKSAR.

Hong Kong Visit/Transit Visa Fee

If an applicant is unsuccessful to acquire a PAR, he/she has to instantly apply for a valid VISA directly with the help of the Hong Kong Immigration Department. The **visa fee is 190 HKD** per passport and has to be paid through a Bank Draft.

SINGAPORE.



When you are looking for a place where you will find thrill, fun, and happiness, then Singapore is an option you can consider! Famous for its night-life and spectacular green sanctuaries, tourists in Singapore have enough to explore and experience. Singapore Changi airport is one of the largest airports in the world and is an attraction in itself for tourists and transit travelers across the world.

A magnificent place that fascinates families, solo travelers and young travelers alike. Some of its famous attractions include the Singapore Shopping Festival, the world's largest wind tunnel for indoor skydiving, sports activities, and the infamous and art lover's paradise, The National Art Museum! Before we dig deeper into its other attractions and lengthy travel itineraries, let's get into the most important bit of it all, the visa! Indian citizens need an approved visa for traveling to several destinations across the globe, Singapore being just one of them too!

Singapore Tourist Visa

The rapid increase of tourists traveling to Singapore has made the process a lot easier and quicker. The tourist visa issued by the embassy permits tourists for a maximum stay of 30 days and comes with a validity of 2 years. This is a multiple entry permit which means every time you travel to Singapore, you don't have to apply for a visa! It would take about 3-4 days in order to get the Singapore Tourist Visa. But be wise and apply at least 7 days before, considering all of them to be working days, your travel.

How to apply for a Singapore Tourist Visa from India?

The procedure to apply for the Singapore Tourist Visa from India is simple and it follows like:

- * Download the Singapore Tourist Visa form (14-A) online and fill in the details carefully.
- * Make sure that your passport has validity as specified.
- * Make sure you have the air tickets to be enclosed with the visa application.
- * A covering letter by the applicant stating the reason, date, and places of travel. The letter should be addressed to "The Embassy of Singapore".
- * Submit the income tax papers and bank statement of last 3 years especially if you are a first-time traveller.

- * Produce address proof. If the place where you reside has a different address from the one mentioned in the passport, then the proofs for both will be needed.
- * Attach the confirmed booking of the hotels in Singapore.
- * After you have submitted all the documents either in person or online, pay the fees for the visa.

You can then wait for the visa processing and till the time you receive any confirmation.

Documents required for Singapore Tourist Visa from India

Every country has its own set of rules for visa processing. It is mandatory to furnish the credentials to get your approval for a visa application. Well in the case of Singapore, you should have documents like:

- * Indian Passport, valid for 6 months at least from the expected date of entry to Singapore.
- * If you have an old passport, enclose it also.
- * 2 recent passport size photographs of the dimension 35mm X45mm with 80% face close up, matte finish and white background. The color of the top you wear should be in contrast with white. One photograph to be pasted in the passport with the glue and signed across. While the second photo goes with the visa application form.
- * Air Tickets for both inward and outward journey.
- * Bank Statement of the last 3 months.
- * Visa Application Form-14 A.
- * Cover letter entailing details of the purpose of your visit to Singapore.

Singapore Visa Fee

The visa processing fee for Indian Citizens is 30 SGD for each individual. This fee is not refundable in all the situations and is applicable if you go through the embassy. Other than this, there are some agents who can get the visa for you but they charge fees for it.

USA.

US Visitor Visa (B2)

The B2/B1 US visa is a non-immigrant visa which allows foreign nationals to enter into the U.S. temporarily for activities like tourism, visiting friends and relatives, medical care, participation in conventions, conferences, etc. The US visa for Tourist and Business purposes allow applicants to stay for a period of 6 months with multiple entries valid for up to 10 years.

How to Apply for B2 Tourist Visa

There are several steps to apply for a visa. The order of these steps and how you complete them may vary by U.S. Embassy or Consulate.

1. Complete the Online Visa Application

- **Online Non-immigrant Visa Application, form DS- 160**– You must: 1) complete the online visa application and 2) print the application form confirmation page to bring to your interview.
- **Photo** – You will upload your photo while completing the online Form DS-160.

2. Schedule an Interview

Interviews are generally required for visa applicants with certain limited exceptions below. Consular officers may require an interview of any visa applicant.

3. Appointment Wait Time

Check the estimated wait time for a non-immigrant visa interview appointment at a U.S. embassy consulate.

4. Gather Required Documentation

Gather and prepare the following required documents before your visa interview:

- Passport valid for travel to the United States – Your passport must be valid for at least six months beyond your period of stay in the United States.
- Non-immigrant Visa Application, form DS- 160 confirmation page.
- Application fee payment receipt, if you are required to pay before your interview.
- Photo – You will upload your photo while completing the online Form DS-160.

5. Additional Documentation May Be Required

Additional documents may be requested to establish if you are qualified. For example, additional requested documents may include evidence of:

- The purpose of your trip,
- Your intent to depart the United States after your trip, and/or
- Your ability to pay all costs of the trip.

6. Attend Your Visa Interview

A consular officer will interview you to determine whether you are qualified to receive a visitor visa. You must establish that you meet the requirements under U.S. law to receive a visa.

US Visa Documents required

Must have Documents for US Visitor Visa:

- * Original Passport with at least 6 months validity and minimum 3 blank pages + all old passports if any;
- * Printout of your form DS 160 confirmation;
- * Appointment letter confirmation;
- * US Visa Fee Payment Receipt;
- * 2 recent colour photographs (Photo Specification);
- * Personal Covering letter (For Employed - Plain paper/ For Self-Employed - Letterhead);
- * Original updated Bank Statement with sufficient bank balance (last 6 months);
- * Income Tax Returns / Form 16 for last 3 years;
- * Supporting Financial Documents such as Fixed Deposits, Property Investments, Recurring Deposits, any other Investments etc (Optional but advisable).

US Visitor Visa Fee

The application fee for the most common non-immigrant visa types is US\$160. This includes tourist, business, student, and exchange visas.

Tourist Schengen Visa

A Tourist Schengen Visa permits third-country nationals to enter the Schengen Area for a maximum of 90 days within a 6-month period, under the purpose of travelling or visiting Europe for pleasure. Non-European citizens willing to travel to Europe for tourism purpose might be required to apply for a short-term Schengen visa under the “tourist” specification. It is advisable to apply for a Schengen Tourist Visa at least 2 weeks prior to the planned trip.



How to Apply for a Tourist Schengen Visa?

To complete your Tourist Schengen visa application successfully, follow these steps:

- * Make sure you qualify for a Tourist Schengen Visa. Due to the fact that there are several Schengen visa types, you must make sure that the visa you need is this one.

- * **Valid passport:** No older than ten years and with a minimum validity of three months beyond your planned stay in Schengen. It must have at least two blank pages in order to be able to affix the visa sticker.
- * **Roundtrip reservation or itinerary:** A document that includes dates and flight numbers specifying entry and exit from the Schengen area. Find out how to get a flight reservation for a tourist visa application.
- * **Travel Health Insurance:** Evidence that you have purchased health insurance that covers medical emergencies with a minimum of €30,000, for your whole period of stay. The Insurance policy can easily be purchased online from AXA Schengen or Europe Assistance.
- * **Proof of accommodation:** Evidence that shows where you will be staying throughout your time in Schengen.
- * **Hotel/hostel booking:** With name, complete address, phone and e-mail, for the entire time you will be in the Schengen area.
- * **Rent agreement:** If you have rented a place, in the country you will be staying.
- * **Letter of tour organizer:** If you will be travelling with a tour agency.
- * **Proof of financial means:** Evidence that shows you have enough money to support yourself throughout your stay in Schengen.
- * **Sponsorship Letter:** When another person will be financially sponsoring your trip to the Schengen Zone. It is also often called an Affidavit of Support.
- * **Travel Itinerary:** A description of your trip to Europe, your purpose of travelling, which places are you going to visit in Europe, the time frame and all the personal data.

Tourist Schengen Visa Fee

The Schengen Visa (Adult) costs around EURO 80 fees and Schengen Visa for child between 06-12 years of age costs around EURO 60 of fees.

Ireland Tourist Visa

An Ireland tourist visa is also referred to as an Ireland visit visa. It is a pre-entry clearance which allows the holder to travel to Ireland, where they can go through Border Control and request permission to enter the country as a tourist or visitor. The Ireland tourist visa is only valid for a maximum of 90 days, but it can be less. It is the Immigration Officer who decides how long you are allowed to stay in Ireland.

There are two types of Ireland tourist visas:

- * Single-entry, and
- * Multiple-entry

With an **Ireland single-entry tourist visa**, you are allowed to only enter the country once. After you leave, you cannot re-enter, even if you still have remaining days on your visa.

An **Ireland multiple-entry tourist visa** allows you to enter and leave Ireland as many times as you want, as long as your Irish visa is still valid. However, a multiple-entry visa is only issued in specific cases, such as if you have previously received Ireland visas or need to make short, frequent trips, such as for business.

How to Apply for Ireland Tourist Visa

The Ireland Tourist Visa application is done online. After completing the online application, you have to print the application form and submit it along with your passport and the Ireland tourist visa documents at a visa application center/office.

To obtain a Tourist visa for Ireland you must go through the following steps:

1. File the online application form.
2. Find out where to submit the application.
3. Collect the documents.
4. Pay the fees.
5. Submit biometrics.

Must have Documents for Ireland Visitor Visa:

- A valid passport and visa.
- A letter stating the reason for your travel to Ireland (ie. for tourism purposes), which you must sign.
- A letter of invitation from a family member or friend in Ireland, if you have a host.
- Proof of accommodation, such as a hotel booking or letter from your host stating they will accommodate you.
- Proof you can support yourself financially, or that your host can provide for you.
- Evidence of air ticket reservation.
- Proof that you will return to your home country after the Ireland tourist visa ends, such as family ties, a work contract, ongoing studies, ownership of property etc.
- Proof you have no criminal records.
- Details of any previous visas even rejected ones.

Ireland Visitor Visa Fee

You also have to pay an Ireland tourist visa processing fee. For a single entry tourist visa for Ireland, you must pay €80, while the cost of multiple-entry tourist visas is €100.

South African Visitor Visa

Applying for a South African Visitor Visa for international travellers (citizens of other countries) who have permanent residence outside South Africa and who wish to visit the country on a temporary basis for tourism or business purposes is valid for a period of 90 days or less. It can take around 3 working days in order to process the visa. Individuals should make their applications in advance to avoid delays in their travel plans.

Documents Required To Apply For South Africa Visa:

- * A passport with a validity of at least six months
- * 2 passport size photos
- * Old passports and visa
- * A copy of your completed and signed visa application form
- * Details about your itinerary
- * Proof of hotel bookings, flight bookings
- * Copy of return ticket
- * A cover letter with all the required details about your itinerary
- * Proof that you have enough finances to fund your visit
- * Bank statement of the last 6 months
- * Income tax returns for the last 3 years
- * Yellow fever vaccination

South Africa Tourist Visa Fees

The Single entry visa is valid up to 3 months and it takes 6-10 business days to process the application. The total cost is approx. Rs. 14575.84. But the multiple entry visa is valid up to 3 months and takes 6-10 business days to process and it costs Rs. 14575.84 per applicant.

Dubai Embraced Huge Number Of Travellers 80% Indian

Dubai welcomed 3.97 million international overnight visitors between January and March 2022, including 3,76,000 from India, placing the city firmly on track for a momentous year, Dubai's Department of Economy and Tourism said on Wednesday. Around 1.27 million international visitors, including 3,20,000 Indians, had visited the city during the same period of the previous year, according to data released by the Department of Economy and Tourism (DET) of Dubai.

Indian is ranked number two among the top source markets after Oman, while Kingdom of Saudi Arabia (KSA) ranks number three followed by the UK and Russia. "Dubai's ability to surpass other major global cities in key tourism indicators demonstrates the success of the far-reaching vision of His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of UAE and Ruler of Dubai, to create a hub for business, investment, entrepreneurship and tourism that rivals the world's best," said Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum, Crown Prince of Dubai and Chairman of The Executive Council of Dubai. March 2022 was an exceptional month for post-pandemic tourism arrivals as the city welcomed 1.78 million international visitors, a 11 per cent jump from the pre-pandemic period.

"These results attest to the emirate's ability to develop a compelling new value proposition in a changed global environment and create innovative new offerings that meet the needs and preferences of the most discerning global travellers. In addition, the vast global diversity of its visitors reflects Dubai's appeal as a destination that cuts across nationalities, regions and continents, and its growing status as a city that bridges global markets and cultures," he added.

According to the DET data released at the ongoing Arabian Travel Market (ATM) in Dubai, the number of international visitors during January-March reflected the best first quarter performance since the outbreak of the COVID-19 pandemic, creating a clear pathway for the city to progress towards its coveted goal of becoming the world's most visited destination.

The city had welcomed 1.61 million overnight visitors in March 2019.

In the first quarter, hotels in Dubai also witnessed significant growth across key hospitality metrics, it added.

Singapore Tourism Numbers Soar As It Commits To Remaining Open, Indian Visitors Ranked First

Singapore tourism numbers have been climbing since it re-opened its borders to foreign visitors earlier this year with Indians making the largest number of visitors by country of origin.

The island city-state now accepts all fully vaccinated travellers from around the world without any need for testing or quarantine.

Looking around the tourist areas, one can see signs of tourists returning and various businesses gearing up for more visitors from abroad. Popular tourist services like open top tour buses and trishaws (three-wheeler bicycles with a seat by the side) have suddenly made an appearance in Suntec City and Rochor Road respectively. A sight last seen pre-COVID.

Indeed, April saw tourist arrivals more than double from March's figure of 121,200 to 294,200. This is based on numbers published by the Singapore Tourism Board. However, this is still a far cry from the 1.638 million average monthly visitors Singapore received in the last pre-COVID year in 2019. Over 300,000 of these came from China, Singapore largest tourism source pre-pandemic, which is still largely closed to travel.

Indians are making up for the missing Chinese and have since the beginning of the year, been the largest group of nationals travelling to Singapore. About 95,500 Indians entered Singapore from January to April. Second are Indonesians at 89,700 and third, Malaysians with 45,600 making the trip by air to Singapore. In these numbers, Singapore does not count Malaysians coming into the country by the land border which has now fully re-opened as the majority of those who use this route, come daily to study or to work.

One of the companies benefiting from Singapore's re-opening is its flag carrier Singapore Airlines.

Last week, during its annual financial reporting, the airline reported that it narrowed losses in the second fiscal half year which ended in March. For the entire year, it posted a net loss of SGD 962 million (USD 697 million) for the year, an improvement of 77.5 percent or SGD 3,309 million (USD 2,398 million). It had a profitable fourth quarter.

Singapore Airlines said that it carried 1.45 million passengers in April, the most since the pandemic. As international borders re-open and people begin to travel again, the airline expects to reach 61 percent of pre-COVID passenger capacity by June and around 67 percent of pre-COVID levels by September. By September, it also expects to server over 70 percent of its pre-COVID destinations.

Australian Travel To Witness The Post Covid Come Back

Australia has seen a bounce back in visitor visa applications from Indian tourists since the full reopening of the country's borders on February 21, 2022.

The Australian government announced a number of initiatives to encourage visitors to return, including the ability to apply for a free visitor visa if one had a visa and was not able to use it due to the pandemic. The island nation is also offering a visa application charge waiver for tourists whose visa to Australia has either expired or is expiring between 20 March 2020 and 30 June 2022.

The continent has progressively been reopening its borders to fully vaccinated travellers, first allowing students, parents and migrants, before reopening to all visitors from February 21.

“Due to increased demand everyone is strongly encouraged to lodge their applications well in advance. An Australian visitor visa is valid for between 12 months and three years from the date it is granted. This means that you can apply for a visa early and then book your travel for a time that is convenient for you,” the Australian government said in a statement.

“Australia has a highly attractive visa offering for tourists. Visa applications can be lodged online at a time and place that suits you best. Online lodgement offers other benefits such as electronic payment and the ability to check the status of your application online. An online application can also be completed by a third party such as a travel agent, with the applicant's permission,” it added.

A “digital passenger declaration” (DPD) has replaced the Australia Travel Declaration. Passengers flying into Australia will now have to complete the DPD before they can enter the country. One can start DPD seven days before their flight and submit it within 72 hours prior to departure for Australia.

“This is because you must provide your health information and declaration (vaccination status and Covid-19 test result) within 72 hours before your flight.

Ease The Travel: South Africa to Initiate e-Visa Facility For Indians

The South African Tourism on Monday said it is eyeing 64 per cent year-on-year growth in arrivals from India in 2022, capitalising on strong consumer demand in the country through various marketing initiatives including roadshows.

India continues to be one of the top-three focus markets for South Africa, which has outlined a strategic road map to garner 64 per cent y-o-y increase in Indian visitors in 2022, the South African Tourism said in a statement.

As part of post-pandemic revival plans, South Africa will introduce e-visas for Indians to attract more tourists, business travellers and movie-makers.

The destination, which remains open to Indian travellers, is also processing tourist visas on priority. India served as the eighth-largest international source market for South Africa and the country is expected to maintain its position in the top-10 this year as well, it said.

Mumbai, Delhi, Bengaluru, Chennai and Pune continue to be top Indian source markets to South Africa. Currently, several stop-over flights fly from India to South Africa, including Emirates, Etihad, Qatar Airways, Air Arabia, Ethiopian Airlines, Kenya Airways and Air Mauritius.

Travellers from India to South Africa will be required to produce a negative PCR (polymerase chain reaction) test, not older than 72 hours from the time of departure from the country of origin to South Africa, the tourism board said.
