5 Great Upcoming Pathways To Move In To UK

Citizens from all over the world move to the UK every year with hopes of settling and living in UK with their dream job or exploring a promising business opportunity, or simply because they feel a connection to the place, they have been wanting to live in. Today the United Kingdom is one of the most popular destinations for a better life because it offers a great way to harness your potential and enjoy a dynamic new culture simultaneously.



The UK is always and still a major & popular destination for those looking at an overseas career. The country is a favored choice for immigrants not only for its educational but also the professional opportunities that it offers. Apart from this working in the UK comes with its own benefits. However, the UK government has launched some of the new ways and visas that can help you get in this dream country and be your own king!

1 SCALE-UP VISAS

The aim of the Scale-up visa is to make it easier and quicker for companies experiencing rapid growth to hire the best skilled labour from around the world.

Under this visa:

- * An individual must hold a high-skilled job offer with a salary of at least £33,000 and meet an English language requirement.
- * Scale-ups will be able to apply to use the route through a fast-track verification process.

To be eligible for this visa:

- * An annual average revenue or employment growth rate over a 3-year period greater than 20%.
- * A minimum of 10 employees at the start of the 3-year period.

The route is set to launch in Spring 2022 and will be open to applicants who pass the English language requirement and have a high-skilled job offer from an eligible business with a salary of at least £33,000 (higher than the salary requirement of £25,600 for Skilled Workers).

Both the Skilled Worker visa and the Scale-up visa are part of the points-based immigration system and require a job offer from a UK employer. However only the Skilled Worker visa requires applicants to be formally sponsored.

2 HIGH POTENTIAL INDIVIDUAL VISA

The High Potential Individual route will be open to high potential graduates from top global universities. The definitions and eligibility requirements for 'top global university' and 'high potential graduates' have yet to be defined, but are likely to respectively include a closed list of government-approved institutions, and characteristics such as age, salary and postgraduate qualifications.

This route will allow:

- * Graduates to relocate to the UK without first having secured a job.
- * Settlement in the UK – again, the parameters and requirements of eligibility for permanent residence under this route have yet to be defined.

This route will allow innovative overseas businesses greater flexibility in transferring workers to the UK to establish and expand their businesses.

This route will allow:

- * People who need intra-company transfers.
- * Facilitate the establishment of branches or subsidiaries.
- * Enable workers to come to the UK to undertake a secondment or short assignments.

A 'revitalised' Innovator route has been announced which will enable overseas innovators and entrepreneurs to start and operate a business in the UK that is either venture-backed or is harnessing innovative technologies.

Under this route:

- * There will be greater flexibility as there will no longer be a requirement for applicants to have at least £50,000 in investment funds, provided that the applicant has sufficient funds to grow their business. Applicants will also be able to undertake work outside their primary business on this route.
- * Business eligibility criteria will be streamlined and simplified for applicants who will need to demonstrate that their business has the potential to grow, add value to the UK, and remain innovative.
- * An option will exist to fast-track applications whose business ideas are 'particularly advanced' will have this option available to them.

A Global Talent Network is set to be launched in 2022 which is intended to help identify talented people to bring to the UK to work in key science and technology sectors.

Launching initially in the Bay Area and Boston in the US, and in Bengaluru in India, the Network plans to work with UK businesses and research institutes to identify UK skill needs. It will subsequently source talent from overseas universities, innovation hubs and research institutions to bring to the UK.

The Network will also provide individuals with tailored advice and links to UK-based opportunities. While there is little information currently available, it has clearly been introduced to advance the Government's intention to attract the best talent from around the world.

The New Immigration Route For Indian Nationals, 'Youth Mobility Scheme'

What is the Youth Mobility Scheme?

The Youth Mobility Scheme visa is available to young adults from participating countries and territories who wish to experience life in the United Kingdom for a period of up to two years.

Youth Mobility Scheme visa holders are allowed to work in the UK, other than as a professional sportsperson or sports coach. They may also undertake studies.

Dependants are not eligible to apply on the Youth Mobility Scheme visa route and it is not a route that

leads directly to settlement in the UK. However, prior to a Youth Mobility Scheme visa expiring it may be possible to apply from within the UK to switch into another immigration category, such as the Skilled Worker route or the Start-up route. Our immigration barristers can advise on potential long term immigration routes, including routes which can lead to settlement in the UK.

What is the Youth Mobility Scheme ballot?

Nationals or citizens of certain countries and rightful holders of passports issued by certain territories must submit an expression of interest in applying for a Youth Mobility Scheme visa and be issued with an invitation to apply before they are eligible to apply for entry clearance on the Youth Mobility Scheme.

You will need to submit an expression of interest by entering the Youth Mobility Scheme ballot if you wish to apply for a Youth Mobility Scheme visa and you are from:

- * Hong Kong (if you have an SAR passport)
- * Japan
- * South Korea
- * Taiwan
- * India

The Home Office will select at random all those who are invited to apply for a Youth Mobility Scheme visa from the pool of individuals who submit an expression of interest by entering the ballot.

Eligibility Criteria for Indian nationals

Youth Mobility Scheme rules and eligibility criteria are confusing as different rules apply to Indian national applicants than those for other countries. If you are an Indian national applying for a place under the scheme you will need to:

- * Meet the general eligibility criteria for UK entry clearance – in other words, you can't have criminal convictions for certain offences and
- * Pay an application fee – the amount is currently £244 and

- * Pay the Immigration Health Charge – the amount is currently £1,248 and
- * Provide your passport or travel paperwork to prove your identity and nationality and
- * Meet the financial requirement - you will need to have held the required minimum specified money for at least twenty-eight days and
- * Provide evidence of sponsorship from India. The sponsorship documents cannot be more than six months of age. Sponsorship is limited to 3,000 places on the scheme for Indian nationals and
- * Meet the education qualification or work experience requirement – to meet the education eligibility criteria you will need to have a qualification equal to or above RQF level 6 and be able to provide evidence of the qualification from the institution that gave you the qualification. Alternatively, you can meet the criteria through work experience. This means you need to have a minimum three-years work experience in a job that is equivalent to an eligible occupation contained in the skilled occupation list. This list is produced by the UK government. Evidence of work experience is required. Immigration lawyers can advise on the best evidence to produce in support of your Youth Mobility Scheme application.

How much it costs

You will need to:

- * pay the application fee
- * pay the healthcare surcharge, which is usually £470 per year - you can check how much you'll have to pay
- * prove you have enough personal savings.

Money to support yourself

- * You must have at least £2,530 in your bank account to show you can support yourself in the UK.
- * You will need to have had the money available for at least 28 days in a row. Day 28 must be within 31 days of applying for this visa.
- * You'll need to show proof of funds while applying.

A residence permit as 'start-up' gives ambitious starters a year to start an innovative company in the Netherlands. One condition in this regard is that they are supervised by a reliable supervisor (facilitator) in the Netherlands. Start-ups receive a great deal of support in the Netherlands to develop into successful enterprises. This is good for the entrepreneur, but also good for employment and the economy.

This residence scheme is being introduced in the form of a pilot and has a duration of 4 years. Start-up companies often have a remuneration structure that does not fit in with existing procedures, such as those for a residence permit for highly skilled migrants. With this pilot 'essential start-up personnel', starting, innovative companies in the Netherlands will be able to attract and retain employees with specific high-quality expertise, experience and skills in an early phase of the development of the start-up company.

Why start up a business in the Netherlands? The Netherlands is in the top 5 of the most competitive economies in the world. We have much to offer foreign entrepreneurs and investors: the accessibility by road, rail, ports and airports is excellent. In addition, our digital infrastructure is one of the fastest and most reliable in the world.

With a good business climate also come good living conditions. The Netherlands also takes a world-leading position in (international) education, healthcare and recreation.

CONDITIONS FOR THE ESSENTIAL START-UP PERSONNEL

There are general guidelines that apply to everyone applying. Besides these conditions the following conditions apply for you and your employee:

- * You have a beginning and innovative company (start-up) with scalable activities. Scalable activities means the company can grow with the demand for the product or service. The start-up is innovative in the following situations:
 - # The product or service is new for the Netherlands;
 - # The start-up uses new technology in production, distribution and / or marketing;
 - # The start-up has a new way of working and organising.
- * A maximum of 5 foreign employees of the start-up will receive a residence permit for essential start-up personnel. An application for the 6th employee will be refused.
- * The employee is an expert in a special field that the start-up needs in this beginning phase.
- * The employee has an employment contract with the start-up.
- * The employee meets the income requirements.
- * The employee receives a share of at least 1% in the company (employee participation). The employee receives this share as:
 - # Shares in the company;
 - # Depository receipts for shares in the company;
 - # Stock options. A stock option is the right to buy shares in the company. The price for these shares is agreed in the contract.

- * The employee receives the shares at the latest 3 years after the contract has started.
- * The employee is always entitled to the shares. There are no conditions for this, such as delivering certain performances.

STEP-BY-STEP TO APPLY

The start-up entrepreneur must undertake specific activities to progress from concept to business. The Government wants to know in advance what activities will take place. The start-up entrepreneur provides a description of this in a step-by-step plan. The step-by-step plan provides:

- * Information on the organisation. The start-up entrepreneur must play an active role in the organisation. This means he is not merely shareholder or financier. The step-by-step plan must detail the following:
 - o The structure of the organisation.
 - o The assigned roles and tasks.
 - o The legal form of the company.
 - o The personnel.
 - o The purpose of the company.
- * A description of the proposed innovative product or service (see What makes a product or service innovative?).
- * A description of the planning and activities associated with setting up the company.

The Netherlands Enterprise Agency (RVO) evaluates the start-up and checks compliance with the step-by-step plan.

WHY YOU CAN CHOOSE TO IMMIGRATE TO LUXEMBOURG

One of the smallest countries in Europe, in population and also geographically, moving to Luxembourg from the USA might seem like a huge change. But don't let its size fool you – home to a thriving expat community and one of the strongest economies in Europe, it is no wonder more and more people are choosing to migrate to Luxembourg. Luxembourg a land of immigration

For a long time now, Luxembourg has been a land of welcome for many immigrants who come here to find a job, among other things. It was the Italians who arrived after the Second World War until the mid-sixties. They were followed by the Portuguese, who arrived in Luxembourg in several waves, corresponding to the crises in Portugal: end of the sixties, 1975-1982, 2003-2009. Since 2014, French immigration takes over. In 2019, they represent nearly 15% of migrants.

Tax haven of Europe

Luxembourg has been a tax haven of choice for corporations and the wealthy since the 1960s, when the small European country rose as a financial center for the off-shore trade of European bonds. Luxembourg was popular with companies looking to issue debt because it lacked a withholding tax, did not require a stamp duty, and did not require bond issuers to publish a prospectus.

A favorable tax regime encourages corporations to establish special purpose entities in Luxembourg. One benefit is the lack of withholding taxes on interest payments and royalty payments, which may allow these payments to escape taxation in the jurisdiction in which these receipts were generated.

Become permanent resident in 5 years

If you have lived in Luxembourg continuously for 5 years, you may apply for a Permanent Residency. Citizens of EU member states and their dependents can also apply for a Permanent Residence permit. You may apply for a PR to the Immigration Directorate of the Ministry of Foreign & European Affairs. Before you apply, you must be able to prove that you were a lawful resident of Luxembourg for at least 5 years continuously.

No language barrier

The three official languages of Luxembourg are Luxembourgish, French, and German. English is widely spoken although it's always worth learning the basic French phrases as it's the main communication language.

Here's How You Can!

Living in Korea offers expats an exciting life in a very advanced and modern country. South Korea is renowned as one of the world's leading producers of technical goods such as mobile phones, televisions and computers. It is also a place of both natural beauty and modernity and the major cities in South Korea are progressive whilst also embracing their past; it is possible to observe modern glass skyscrapers side by side with some of the fortresses, temples and palaces that have now become UNESCO world heritage sites.

The Ministry of Education and Korean universities have been actively promoting 'Study in Korea' with a view toward increasing international competitiveness, international exchanges and cooperation. As of April 2016, there are roughly 104,000 international students studying in Korea, among which 63,000 students are in degree programs.

Fully Funded Scholarships for International Students

Scholarships funded by global and regional organizations allow you to study at any country or a wide selection of countries. Due its nature, distance learning scholarships allow you to pursue international studies in your own country or wherever you may be. You can opt for scholarships which are related to your particular field and apply for the same within the given timeline. Find them here at <https://www.studyinkorea.go.kr>

Apply for Bachelors, Masters or PhD

Another good option to move to Korea is to apply as a foreign student and join a degree program offered during the regular semesters with Korean students. Degree programs are taught either in Korean or English, After completion, a degree is awarded.

However, graduate schools are divided into general graduate schools within universities which offer academic programs and professional graduate schools which offer practical skills. Master's programs require two or more years of study and 24 academic credits in general. Doctoral programs require three or more years of study and 36 credits in general. Graduate schools also offer post-doctoral programs for those who want to continue research after acquiring a doctoral degree.

Special Scholarships for Countries Like India

Official Korean government websites have many Global Korea Scholarship programs which are country specified and some of them are general to apply for. Work Route

India CEPA with Korea

The Comprehensive Economic partnership Agreement (CEPA) between India and the Republic of Korea came into force from 01 January 2010. Article 8.3 covers the movement of professionals from either of the countries to the other for business and employment. It has 163 Professions from which professionals can seek employment in each other's country.

Indian professionals can now seek opportunities in ROK to undertake projects/contracts. Indian professionals can access ROK services market as under:

- a) Directly by the Korean company or Indian company based in ROK or
- b) Applied for by the Indian professional to the Korean company or

2) Skilled Nominated Visa (Subclass 190):

In order to apply under this visa, one should possess sponsorship from a suitable relative living in some designated area or by a state or territory government. Nearly every province and territory operates the PNP to welcome skilled workers from all over the world to help strengthen their economies. Each PNP has at least one immigration stream that is aligned with the federal Express Entry immigration selection system. Provincial nominations issued under these Express Entry-aligned streams are known as 'enhanced nominations'.

The benefits of enhanced PNP streams are that they award Express Entry candidates an additional 600 Comprehensive Ranking System (CRS) points, which essentially guarantee they will receive a permanent residence invitation under Express Entry. A work permit under the PGWP is usually issued for the length of the study program. The maximum length of the PGWP in Canada is of three years. It means if your post-graduate course's duration is two years, you get a three-year PGWP visa. A post-graduation work permit cannot be valid for longer than the student's study program. The course duration must be a minimum of eight months to get post graduate work permit in Canada. The Post-Graduation Work Permit Program (PGWPP) allows international students who completed their higher education in Canada from designated learning institutions (DLIs) to obtain an open work permit and remain and work in Canada. The post-graduation work permit in Canada allows students to stay there and gain work experience after completing their graduation.

If You're Dreaming To Live In UK, Apply Via New Point-Based Immigration System



EU unskilled migrants will be ineligible to get into the UK, after the introduction of a new points-based immigration system last Wednesday, in a bid of the government to take over the control of the borders and to restore the trust of the citizens of UK.

From the new points-based immigrant system, according to the UK Home Secretary Priti Patel, will take profit only the applicants who will gain enough points from specific skills, qualifications, salaries or professions.

The Home Secretary Priti Patel said that the new decision that will come to force from 1 January 2021, will bring the migration numbers down. European Union (EU) citizens not already living in the UK have been treated the same way as those from the rest of the world.

It means that anyone wants to live and work in the UK has to apply via a points-based system. The points-based visa system is the main UK immigration route for migrants from outside the European Economic Area (EEA) to come to the United Kingdom, to work, study, invest or train, which separates applicants into five 'tiers'.

The system is designed to ensure that no one who might jeopardize the health of other persons in the UK is admitted. Furthermore, those unable to support themselves or their dependants in the UK for medical reasons, and those that require major medical treatment (unless explicitly granted), will not be granted with any of the points-based system visas.

The Eligibility For Point Based System

In order to be eligible for a visa in any of the five tiers you must pass a points-based assessment. Each tier has different conditions, entitlements, and entry requirements for people wishing to live and work in the UK and each tier will necessitate you to allocate a sufficient number of points to gain entry clearance or leave to remain in the United Kingdom. Points are allocated according to traits, such as age, qualifications, earnings, language and funds, with a different number of points needed for each of the five tiers.

The ability to fund your initial stay in the UK and your ability to speak English will play a very significant role in most cases.

Factors on which the candidate will be judged:

Age

Depending on the age, one can allocate 5 to 20 points. The system privileges young applicants assessing them with more points than those older.

English Language

Each applicant must obtain 10 points for English language ability. Nationals of countries where English is an official language automatically obtain ten points, while nationals of other countries must first take a test to prove their English ability.

Qualifications

Some tiers assess education level from 30 to 50 points and others from 5 to 15 points.

Earnings/Maintenance

Depending on the tier earnings or maintenance, candidates financial means are assessed with 15 to 45 points of 5 to 20 points.

UK experience

Some of the tiers may evaluate the experience that one has had in the United Kingdom with 5 points.

Certificate of Sponsorship

CoS is evaluated with **30 to 50 points**.

An Example Of Eligible Scenario

- * To qualify for a visa, migrant workers who want to move to the UK will have to qualify for 70 points.
- * Having a job offer from an approved employer for a skilled job and being able to speak English will give 50 points.
- * The applicant can achieve the remaining 20 points if they are due to be paid at least £25,600 a year.
- * They can also gain extra points for having better qualifications (10 points for a relevant PhD, or 20 points for a PhD in science, technology, engineering or maths) or an offer of a job in which the UK has a shortage (20 points), even if it doesn't pay as much money.
- * Certain jobs in health or education still merit 20 points even if the salary is less than £25,600. The applicant must be paid at least £20,480, and in line with set amounts for particular jobs in the UK's four nations.

How Much Will It Cost?

The application fee will depend on how many years the job seeker plans to work in the UK, and whether their job is on a list of skills that the UK has shortages of - for instance, vets and web designers.

If their skills are not on that list then the standard fee will be between £610 and £1,408 per person.

Jobseekers will also have to pay a health surcharge of £624 per person per year when they apply - that money is refunded if they don't get a visa.

And they will need to show that they have the means to support themselves in the UK, which usually involves having a total of at least £1,270 available.

Third country nationals who are eligible for the Single

Permit Application still require an employment license, which process is conducted by means of internal arrangements between ETC and the Department for Citizenship and Expatriate Affairs, some of the documentation indicated in the contents below still applies in their respect.

Documentation Required

In the case of an application for a new employment license for a third country national, the process is as follows. The employer, unless it is a single permit application must fill in an application form and submit it to the Employment Licenses Unit by hand or by mail.

The following documentation needs to be provided at application stage:

- * Position description;
- * References/testimonials;
- * One passport photo;
- * Copy of travel document;
- * Copy of valid visa (if third country national is in Malta);
- * Copy of qualification certificates and accreditation/recognition;
- * Covering letter by employer indicating site of work;
- * The fee;
- * Evidence of search for EEA/Swiss/Maltese nationals through a detailed vacancy report.

However, for those who aren't sponsored by their parents or spouse, they can also apply for a freelance visa in Dubai, which is a residency permit that allows the individual to live and work in the emirate and is renewable every three years.

Who Should Apply For The Freelance Permit

There are various sectors for which you can obtain freelancer eligibility in Dubai:

- * Education
- * Media
- * Tech

If you are pursuing professions such as acting, screenwriting, journalism, advertising, training, education advisor, customer service or web development, you are eligible to apply for the freelance visa in Dubai. Please note that the Dubai Internet City will issue your freelance permit if you are working in the Tech sector, Dubai Media City for the media sector and Dubai Knowledge Park for the education sector.

UK Is Set To Gain The Best Talent From India With New Immigration Policy

As we navigate the new immigration rules, policies and procedures, it is imperative to recognise that even for experienced sponsors, there are changes coming in to play with the system that all will need to understand and navigate through.

Many of the positive changes in the new system will benefit employers supporting and sponsoring migrant workers in to the UK. This includes the ability to bring migrants in to a wider range of roles due to the lowering of skills levels and salary requirements and the ability to hire to meet demand without a cap on numbers. Agile, growing businesses and established international networks will want to take advantage of these changes.

UK and India signed an ambitious new migration partnership in May 2021, in an aim to make a major leap in the UK's bilateral relationship with India.

This professional and cultural exchange programme works in a similar manner to the current Youth Mobility Schemes, with India being the first visa national country (i.e., those countries which require visas to visit the UK) to profit from this. The agreement is meant to permit several 18-30-year-olds to work and live in each other's country for up to two years.

According to the most recent statistics, more than 98,000 Indian students came to the UK to study last year, up 90% on the previous year. In addition, the new post-study Graduate Route offers eligible graduates 2-3 years to stay back after studies in the UK – opened for applications in July 2021, offering yet another route for talented young Indians to build careers and experience in the UK, having previously cancelled the Post Study Work (PSW)

route in 2012.

The UK has struggled to fill positions in various industries since voting to leave the EU. In the absence of free movement and the rules thanks to the new points-based immigration system that places emphasis for workers based on education qualifications, skills, English language proficiency and salary, working closely with India may be mutually beneficial for both nations.

Indians continue to relocate to the UK for work & study

Indian citizens have been the largest cohort of non-EU immigrants in the UK for several years and despite the pandemic hitting the world in 2020, Indians were granted more sponsored skilled-worker visas than any other group and typically, recent migrants occupy highly paid roles in the UK.

The UK is in need of workers across a range of professions such as key workers, hospitality, veterinarians, doctors, scientists, architects, artists and more—and will even permit employers to pay 20% below the threshold for visa eligibility for these roles depending on the salary.

Even the pandemic did not discourage Indian students from pursuing their needs of studying abroad. Between 2019 and 2020, 48% more Indians received Tier 4 student visas to the UK, while those granted to Chinese nationals—the largest international student population in the UK—fell by 56%. In 2021, 9,930 Indians applied to UK universities from 7,640 the previous year making a 30% leap. The good news is that there are now more options for Indian students in comparison to the last decade.

Even as thousands of Indian students firm up plans to study in universities in the US in the 2022 Fall season, the US embassy in India is planning a change in the visa application system for those applying in the summer of 2022.

“Last year we interviewed more students and issued more student visas in India than ever before. This year we hope the number of student visas will be even higher than the 62,000 issued last year. However, that will also depend on how well prepared the student visa applicants are,” Donald L Heflin, minister-counselor for consular affairs at the US Embassy in Delhi.

“Last year we faced two big problems; first because of the huge number of student visa applicants from India, our worldwide computer system crashed. Second, a large number of student visa interview slots were bought up by people who were not genuine applicants. Also, while in the first part of the season we had good and genuine students applying for visas; in the later part, last summer, many applicants who we interviewed were coming to us a second or third time having been refused student visas earlier. That was taking slots away from good students,” Heflin said.

The US government has now made software changes to ensure that students who are refused a visa once in the summer-spring of 2022 will not be able to seek another visa interview appointment again this year.

“We hope to address both the problems of non-availability of interview slots for good and genuine students as well as the blocking of slots by non-student agents, who don't show up for the interview, with these measures,” Heflin said.

Canada will be increasing the fees applicable for all permanent residence applications, starting April 30.

Permanent resident visa processing cost differs according to the immigration program you select to apply through. The fee increases will apply to economic, permit holder, family and humanitarian classes.

The Right of Permanent Residence Fee for the applicant and accompanying spouse or common-law partner has been increased by CAD15 to CAD515.

For those applying under Federal High Skilled, Provincial Nominee Program and Quebec Skilled Workers, Atlantic Immigration Class and most Economic Pilots, the following hike applies;

Applicants	Current Fee	New Fee
Principal applicant	CAD825	CAD850
Accompanying spouse or ommon-law partner	CAD825	CAD850
Accompanying dependent child	CAD225	CAD230

Fee for permanent resident cards, permanent resident travel documents and certification or replacement immigration documents will remain the same.

Fees are expected to increase in two years based on the applicable Consumer Price Index increase rounded to the nearest \$5. The next fee increase at the federal level is expected to be announced in 2024.

The United States has announced the expansion of its "premium processing" service to include applicants for an Employment Authorization Document, in a bid to ease its multi-million case immigration backlog.

The Employment Authorization Document allows recipients to work in the U.S. while they seek asylum or other legal status. About 2 million people apply for new or renewed work permits each year, according to USCIS data. The process typically takes five to seven months.

Under the new rule, individuals seeking work permits can pay \$1,500 to have their applications considered within 30 days. The premium fee ranges up to \$2,500 for applications for other kinds of employment-related adjustments in legal status.

The USCIS oversees requests for work permits, asylum, green cards, U.S. citizenship and other immigration benefits, including the temporary H-1B program for highly skilled foreign workers.

The immigration agency has been struggling with backlogs, which was exacerbated by the Covid pandemic. As of February, USCIS was reviewing more than 9.5 million pending applications, a 66% increase from the end of fiscal year 2019, according to agency data.
